AGM16.3.1 Lee Dolby, Director of Development, provided an update on the participation project.

AGM16.3.1.2 Last 12 months progress included the following;

- Launched the National Quality Standard for deaf sport provision 'DEAFinitely inclusive club' and 'DEAFinitely inclusive facility'.
- Developed promotional videos to encourage participation.
- Insight Development through National Survey and developed sports factsheet.
- Education of Coaches:
 - Over 250 training in Effective Communication.
 - 39 new deaf coaches qualified to level 1 and 2.
 - Leadership in Running Fitness Course delivered specifically for deaf people.
- 1st National Conference.
- New Deaf events in Birmingham, York, London, Lancaster, Peterborough, Leeds, Nottingham, Manchester, Sussex, Preston, Exeter.
- · Launch of two new websites.

AGM16.3.1.3

Lee explained that the baseline participation figures had been established. The figures were developed from 3 national pieces of research data namely; Sport England Active People, Family Resource Survey and UKDS National Participation Survey. Total participation in the UK of 169,238 (84,222 in England) of which 87,584 under 65 Years of Age and 81,654 over 65 Year of Age. UKDS also developed participation rate in individual sports and identified potential latent demand and there will be further development to break down to Home Nation figure.

Lee outlined the Plans moving forward which included the following; DEAFinitely inclusive accreditation, Coach Education, Insight and Effective Communication Training.

Key Performance Indicators to measure success had been developed and includes; 12 new activities run through DEAFinitely Inclusive network partners, 108 deaf people participating in DEAFinitely Inclusive clubs, Accrediation of 36 DEAFinitely Inclusive clubs / 12 DEAFinitely inclusive facilities, 20 new level 1 and 2 Coaches and 224 coaches on Effective Communication Training.

RECEIVED & NOTED UKDS Unaudited Accounts 2014-2015.

AGM16.8.1 Gordon Hay, Trustee, on behalf of Philip Gerrard, Chair during the year, gave

the summary of UKDS' Finances for the year end 2015. The results for the year are set out in the financial statements commencing on page 15. The charity secured income of £206,077 (2014 - £183,897) and includes the funding secured from Sport England to deliver the infrastructure and support for the development of deaf athletes. Expenditure amounted to £203,091 (2014 - £227,136) the decrease due to higher expenditure in the previous year relating to Deaflympics. A surplus was generated of £3,204 (2014 – deficit £43,113) resulting in total reserves at 31 March 2015 of £25,957.
