The report showed the Red 22% (14%)*, Amber 34% (45%) and Green 44%

(41%) (RAG) status.

Board members monitored the progress on the business plan.

UKDS14.47.3

Taking an overview of the business plan at year end showed good progress across most areas. Pace of progress in some areas of talent has been slower than expected with greater levels of work needed to bring deaf sports organisation together and challenge historical ways of doing things. Funding remains a major concern and a dialogue is on-going with our main funder, Sport England. Network development continues to be strong with the launch of the London Network successfully gaining support and coverage.

The board considered the challenges mentioned within the report namely Deaflympic planning, National Deaf Sport Organisation Governance review, office hosting arrangement and fundraising.

The Management accounts are broken down into four areas; Core costs £2,653 c/f (£1,031), Talent Development £26,455 c/f £26,455, Inclusive Sport (£21,795) c/f (£579), Sponsorship (£5,592) c/f £50 and Inclusive Sport underspend £38,753. Overall surplus figure £63,640 (restricted £62,660 and unrestricted ((£980)).

Core funding is showing a small surplus year to date with further anticipated income due to be received. This will help reduce the deficit on reserves. This brought forward deficit on reserves relates to a shortfall in core funding over the past 2 years combined with an overspend on Deaflympics.

UKDS14.50.3	Funding has been received for both inclusive sports and talent development in excess of expenditure, which will be balanced out in due course.
TASK	PG to clarify with Accountant on why the income shows a deficit in the inclusive sport accounts.
UKDS14.51	International Committee of Sport for the deaf (ICSD)
UKDS14.51.1	The 45 th ICSD Congress is due to take place between 26 th and 28 th March 2015 in Khanty-Mansiysk, Russia.
UKDS14.51.2	A number of member countries are unhappy with the management of ICSD with a consideration to boycott the event in protest. UK Deaf Sport are concerned that there had been no action by ICSD on one of its member federation, Russian Deaf Sport where a Russian Court found the Russian Deaf Sport Federation guilty of falsifying an audiogram on an athlete.
UKDS14.51.3	UK Deaf Sport notes that the President and CEO of ICSD are from Russia and worked for the Russian Deaf Sport Federation at the time of falsifying the audiogram.
UKDS14.51.4	The board discussed the merits of boycott action and came to the view that UK Deaf Sport should be represented at the Congress.
TASK	PG to hold further talks with other ICSD members to gauge the international viewpoints of the current situation.
